Terms :

- This dog is, to the best of knowledge, free from communicable diseases and has been vaccinated and wormed regularly. It is recommended that buyer's Vet exam the puppy within 48 hours of purchase.
- This dog is being purchased as a companion. The owner agrees to neuter/spay this dog before his first birthday.
- This dog is guaranteed against hip dysplasia, congenital eye defects and all proven genetic defects that will affect the dog in his life as a companion. If the dog exhibits any of the above defects, she/he shall be replaced by a puppy of equal or better quality upon return of dog to breeder, or proof of spay or neuter. **NO CASH WILL BE REFUNDED.**
- This dog is being sold with limited registration papers AKC and ASCA
- This dog will be kept in a safe and proper environment at all times. He will neither be allowed to roam at large or be kept tethered for any great length of time, a fenced yard being the preferred method of restraint.
- This dog will be fed a high quality food for his lifetime. He will have all proper and regular Veterinary care for his lifetime. If this dog is allowed to become clinically obese, then the health related guarantees on this dog become null and void.
- The owner has agreed to train this dog in basic obedience and housebreak him/her.
- If this dog is found to be abused or neglected or mishandled in anyway, the breeder may come onto a premise or enter a building containing this dog and take him back. No money will be refunded.
- If this dog is to leave the ownership of the purchaser, the breeder must be notified and dog will be returned to the breeder.
